1. We understand that the registration fee is due with this form. No registration refund will be given once a child is accepted.
2. We understand that the charges for annual tuition and fees may be paid in ten or twelve equal installments directly to FACTS Tuition Management Company. Should the child(ren) be withdrawn prior to August 1, any prepaid tuition or fees will be refunded, excluding the registration fee. We accept responsibility for the full annual tuition except as noted in #4 below. The monthly payment is due regardless of the number of days attended or the number of school days in a month as monthly installments are for payment of annual tuition.
3. Payments for Daycare are prepaid a month in advance and are due on the first of each month. Payments received after the 10<sup>th</sup> of each month, or if only partially paid, will result in a late charge of \$25.00. There will be a \$15.00 service charge for returned items. Tuition payments made directly to FACTS are subject to the rules of the FACTS program. If account is still past due on the last day of the month, class attendance will not be permitted until arrangements have been made to bring the account to current status.
4. We understand that the school reserves the right to dismiss any student who does not cooperate with the educational process. If the student is transferred or withdrawn from school by the parent or guardian for any reason, the account will be reconciled and a final billing or refund (as appropriate) will be forwarded to the financially responsible party. The DFC, Academic Fee, and Registration fee are non-refundable.
5. We understand that continued enrollment of our student(s) at Alta Loma Christian School requires acceptable academic performance and proper conduct as determined by the school staff and administration. Re-enrollment is conditional on acceptable citizenship and academic progress. We agree to cooperate with the school staff and administration in all matters relating to enrollment of our student(s) at Alta Loma Christian School.
